Liontown

Liontown is an emerging tier 1 battery minerals producer whose purpose is to find, develop and supply battery minerals to the electric vehicle and energy storage industries.

The company's vision is to be a globally significant provider of battery minerals as the world transitions to a low-carbon future.

The Kathleen Valley Lithium Project comprises a lithium processing facility, including renewable power generation, solar farm, accommodation village, open pit, underground mine, tailings storage facility and associated non-process infrastructure.

The Project is located approximately 680 kilometres north-east of Perth and 350 kilometres north-west of Kalgoorlie in the northern Goldfields region of Western Australia. Liontown began construction in 2022, with first production anticipated for mid-2024.

Kathleen Valley is one of the most significant new long-life lithium projects being constructed anywhere in the world.






We require our suppliers to comply with our policies and procedures, including our <u>Supplier Code of Conduct</u>.
